The Chamber continued our legislative advocacy at all levels of government, working proactively to represent our members on issues important to business and facilitating opportunities to interact with policymakers and influencers.

2025 Legislative Agenda

Taxation

Support Tax Policies That Preserve Jo Co's Economy and Quality of Life

The Chamber supports reasonable and balanced income, sales and property tax policies that adequately fund the core state budget while preserving Johnson County's economic competitiveness and quality of life, including:

- Providing responsible and equitable income and property tax relief;
- Maintaining tax rates that do not unreasonably burden or disadvantage Kansas businesses;
- Preserving industry-driven sales tax exemptions;
- Continuing the sales tax exclusion for professional services.

Infrastructure

Maintain Strong Infrastructure and An Efficient Transportation System

As a cornerstone for commercial activity and economic development across the state, the Chamber supports maintaining a strong, efficient, reliable, and cost-effective infrastructure system, including:

- Fully funding the statewide multi-modal Eisenhower Legacy Transportation Program;
- Continuing the direct transfer of state sales tax revenues to the State Highway Fund (SHF);
- Statutorily adjusting the SHF sales tax transfer as needed to hold the SHF harmless;
- Providing ongoing and expanded opportunities for local input and partnership;
- Opposing diversion of SHF sales tax revenues statutorily intended for transportation to other purposes;
- Considering new technology, innovations, and funding sources that would enhance the system.

2025 Legislative Agenda

K-12 Education

Support K-12 Public Education to Build Our Workforce

The Chamber supports K-12 education policies that adequately enables Johnson County students to prepare for post-secondary success and workforce-readiness, does not unreasonably burden taxpayers, or shortchange other core state services;

- Removing the sunset on high density at-risk weighting for individual school buildings, making it permanent;
- Supporting workforce development, including promoting career exploration and training;
- Respecting local control over funding, spending, and curriculum choices.

To help ensure access and quality for all students, the Chamber opposes programs that divert public funds, directly or indirectly, to private alternatives not subject to the same mandates, regulations, and accountability requirements governing public schools.

Post-Secondary Education

Fund a Strong & Affordable Public Post-Secondary Education System

The Chamber supports policies and state investment in public post-secondary education:

- Helping ensure affordable access and quality for all students;
- Promoting programs and partnerships that match workforce needs, including career/technical training and certifications;
- Rewarding efficiency and outcomes;
- Supporting research, development, and commercialization, moving innovation into industry.

2025 Legislative Agenda

Key Business Costs

Respect Employer-Employee Relations

Because employers and employees should remain empowered to decide employment issues based upon individual market circumstances, the Chamber opposes legislation that substantially intercedes in employer-employee relations, including unreasonable mandates or restrictions in hiring, compensating, accommodating, or terminating employees.

Preserve Integrity and Affordability in Unemployment Comp & Workers Comp

The Chamber supports unemployment compensation and workers compensation policies that promote stability and fairness, protect employer costs, reduce administrative burdens, and encourage employment and accountability, including ensuring mechanisms are in place to protect the solvency and integrity of the Employment Security Trust Fund and the Fund modernization project is effectively implemented.

Promote Affordable and Accessible Health Care

The Chamber supports to the extent possible market-driven health care that reduces costs and promotes access, efficiency, prevention and enhanced quality of care without imposing substantial new mandates or penalties, including the expansion and permanence of telehealth authority.

Because most health care costs of low-income uninsured individuals are currently being passed on to others in the system, the Chamber also supports fiscally-responsible Kansas solutions for expanding income-based coverage while continuing to improve the outcomes, efficiency, and provider reimbursements of the state's Medicaid system.

2025 Legislative Agenda

Key Business Costs

Support an Impartial & Cost-Effective Legal System

The Chamber supports a fair, nonpartisan, efficient, stable, and cost-effective legal system to resolve business disputes, including exploring constitutional methods of providing reasonable damages caps.

To help ensure an independent and qualified judiciary, the Chamber also supports a non-election process for selecting judges.

Economic & Workforce Development

Ensure Responsive Economic and Workforce Development

To ensure Kansas remains an attractive place for businesses to locate, the Chamber supports:

- Maintaining competitive and responsible development tools that can attract or retain a variety of job creation, capital investment, and entrepreneurial opportunities;
- Strengthening short-term and long-term workforce development initiatives and minimizing barriers;
- Investing adequate resources in Department of Commerce staff, marketing and programs;
- Implementing the updated vision and strategic plan for economic development in Kansas, focused on targeted industries served by the state's strengths.

Tax Authority

Retain Flexible Revenue & Spending Authority

To ensure elected officials can appropriately respond to circumstances and needs, the Chamber opposes the imposition of state or local tax and spending lids and other unreasonably burdensome mandates for reporting and approving tax or budget measures.

Voters have the opportunity to extend an existing 3/8th cent sales tax that funds street maintenance, park improvements and recreational opportunities throughout Lenexa.

35-40% of the city's sales tax revenue is generated by visitors to Lenexa retailers, not residents.

Ballots will be mailed to registered voters on March 14 and you have until April 1 to return your ballot with a YES vote.

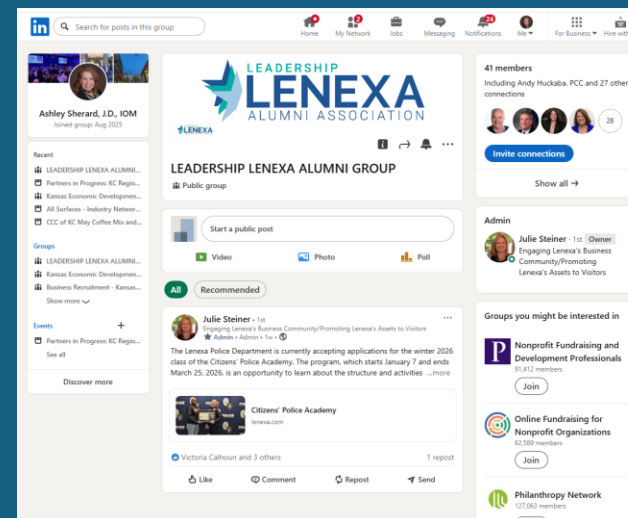
