WELCOME SESSION

WEDNESDAY, JANUARY 28
3:00PM-5:00PM

The welcome session provides the opportunity to meet and greet your fellow participants with an exercise allowing you to introduce yourself before our first session.

ORIENTATION/STRENGTHSFINDER

THURSDAY, JANUARY 29
8:30AM-4:00PM

Prior to the session, we take the StrengthsFinder Assessment to discover our Top 5 Strengths. The session is a full day with Dr. Sondra Cave, the founder and director of Strengths and Leadership Consulting and a Strengths Advisor at Gallup Organization. Dr. Cave will take us through exercises to teach us more about our Top 5 and show us basic strategies to apply them in all areas of life.
